BECOMING A CORPORATE MEMBER OF MUIRFIELD GOLF CLUB

(Info Correct as of July 2011 and subject to change without notice).

- A Company taking up Corporate Membership with Muirfield Golf club will be issued with one Corporate Primary Member's Card for the nominated person, granting the nominee playing rights equivalent to a 7 Day Member. One Company Card will also be issued which will entitle that person to bring up to three guests to the golf course without having to pay a green fee, whenever the tee is available, outside of the Club's competition times.
- Additional Corporate Members (up to three) may be nominated by the company at an additional fee per person. Those persons will be granted a Corporate Member's Card with 7 Day playing rights. There will be no additional Joining Fee for additional Corporate Members. All individual Corporate Memberships will be valid only as long as the company maintains its Company Cardholder's Membership. All persons admitted to Club membership must agree to be bound by the Club's Constitution, By Laws and Policies.
- Where multiple Corporate Membership Cards have been issued under the above conditions the Company Card may only be used to host visitors by one of the Corporate Members once on any one day.
- A Corporate Member may bring one visitor to a member's competition round without green fee on up to 12 occasions per year. This limit applies to the Company as a whole and only visitors with a GA handicap will be allowed to enter a Club competition. No visitor may win any of the Club's major events. Competition fees will still apply.
- A Corporate Member using the Company Card may bring additional visitors (i.e. more than three) and pay the Guest of Member's rate for all visitors in excess of three. All Guests must be in the same group or an adjacent group to the Corporate Member. A Corporate Member who is not exercising the visitor's rights attached to the Company Card will pay the Guest of Member's rate for all visitors.
- The Company may withdraw and reallocate its individual Corporate Membership/s to another nominated person by contacting the Club in writing and having the new nominee fill out a standard membership form. Each Corporate Membership may only be reallocated twice in any one membership year. The new nomination will become active when approved by the Club's Board. A new Corporate Member's Card will be issued once the previous nominee's card has been returned to the Club. The Corporate Member's Card may only be used by the nominated person.
- Length of Membership - Corporate Membership is only available on an annual basis and the Club's membership year is 1st July to 30th June. Multi year arrangements not permitted.
- Offer of Corporate Membership to Registered Companies – Only companies that hold an A.B.N. and registered with A.S.I.C. will be considered for Corporate Membership. Proof of registration may be requested.
- Board of Directors and Voting Limitation – The company and persons nominated as a Corporate Members will not be entitled to take part in the management of the affairs or business of the Club or in the election of office bearers.
- Transfer of Corporate Membership - Corporate memberships can not be transferred to another Company or sold as part of a Company to another Company unless approved by the Board of Muirfield Golf Club.
- Payment Methods – All Fees due are to be paid by cash, cheque or electronic funds transfer in advance of Corporate Membership commencing. Credit card payments are permitted and a 3% transaction fee may apply. Fee instalment facilities offered by the Club for individual memberships are not permitted.
- Corporate Golf Day – A Company holding a Corporate Membership will be entitled to a 20% discount on one corporate golf day per year (Green fee component only).
- General – The Club reserves the right to refuse corporate membership to any company or individual without reason or explanation.
